1. Kelly Peters, 218 Ralston Road, Richmond, Virginia, applying to conditionally rezone 6.71 acres from Residential General District (R-1) to Agricultural Transitional District (A-T) per Section 603B.02-02 of the Land Development Regulations. Property owned by Charles and Darlene Hileman is located on the east side of Valley Pike approximately 350' north of its intersection with Meadowview Drive in the Walkers Creek Magisterial District and further identified as Tax Map 62A-8-2.
2. Brandi Humphries (Harvest Valley), 180 Gilmer Creek Lane, Lexington, Virginia, applying for a special exception permit for an Events Venue in the Agricultural and General Uses District (A-2) per Section 603.03-24 of the Land Development Regulations.
