## ROCKBRIDGE COUNTY NOTICE OF PUBLIC HEARING

Notice is hereby given per Section 15.2-2204 of the Code of Virginia and Section 802.03, 04 and 05 of the County of Rockbridge Land Development Regulations that a public hearing will be held by the Rockbridge County Planning Commission on Wednesday, May 13, 2020, at or after 7:00 p.m. in the Meeting Room in the County Administrative Offices, 150 South Main Street, Lexington, Virginia 24450, followed by a public hearing by the Board of Supervisors on Tuesday, May 26, 2020, at or after 6:00 p.m. at the same location to consider the application for a special exception permit by Brandi Humphries (Harvest Valley), 180 Gilmer Creek Lane, Lexington, Virginia, for an Events Venue in the Agricultural and General Uses District (A-2) per Section 603.03-24 of the Land Development Regulations. Property is located as addressed off of the east side of Sycamore Valley Drive approximately .37 miles north of its intersection with Mohlers Loop in the Kerrs Creek Magisterial District and further identified as Tax Map 33-3-2.

These meetings will be held by electronic means, due to the threats posed by the COVID-19 pandemic to the health, safety and welfare of the public.
