

November 3, 2021

The Rockbridge County Electoral Board met on the above date at 12:00 pm the Rockbridge County Board of Supervisors' Room to canvass the results of the November 2, 2021 election (24.2-671). Present at the meeting were Harry Stone, Richard Hasey, Whitney Huffman, General Registrar Sheila Hall, Doug Smith (Rockbridge Republican Chair) and Jay Clark (Rockbridge Democratic Chair).

The Board started by reviewing 13 provisional ballots. Nine (9) were accepted, three (3) were rejected and one is awaiting voter ID to be presented.

Attached are the results of election by precinct as well as the write-in votes.

The Board adjourned at 6:00 pm to resume on Friday, November 5, 2021 at 12:00 noon to count any absentee ballots posted marked on election day, November 2, 2021, and received by 12:00 noon on November 5, 2021, as well as the provisional ballots accepted at the canvass on November 3, 2021.

November 5, 2021

Board resumed canvass at 12:00 noon in the Rockbridge County Board of Supervisors' Room to canvass the results of the November 2, 2021 election (24.2-671). Present at the meeting were Harry Stone, Richard Hasey, Whitney Huffman, General Registrar Sheila Hall, and Doug Smith (Rockbridge Republican Chair).

The Board accepted one of the provisional ballots from election day that was waiting on an ID since the voter signed the state ID form on the day of the election. A total of two absentee ballots that were presented on or before election day were rejected. One had not been cured before 12:00 noon on 11/5/2021, and the other had been dropped into the City of Lexington drop box and there were concerns about chain of custody.

The Board hand counted the ten (10) provisional ballots from election day that were accepted. Results are below:
