#### Financial Report

Finance Director Steven Bolster reviewed his monthly memorandum.

Activities for the Commissioner included: completed first-half Real Estate tax season; working on monthly DMV report; preparing supplemental tax books for 2013 Personal Property and 2014 Real Estate; starting work on the 2014 Personal Property tax book; auditing business license files to ensure renewals were completed for year; and working on Building

Department Certificate of Occupancies for new construction. Activities for the Treasurer included: sent first-half Real Estate tax tickets with the newly added 4th line of description - full identification of parcel being billed; Auditors expected in the office for 2 weeks in June examining records; and delinquent Real Estate letters to be sent as soon as all mail is processed for the June 5th deadline.

Mr. Bolster reviewed the Revenues versus Expenditures chart, noting that revenues came in above estimate by around \$850,000 - with sales, meals, and lodging revenues exceeding last year's monthly receipt average by around \$14,000. He then noted that expenditures came in around \$600,000 less than projected. Mr. Bolster asked for questions on the Revenues versus Expenditures chart.

Supervisor Ford asked Mr. Bolster to discuss the looming uncertainty over 2014-15 revenues from the state, as discussed in the Finance Committee Meeting on Friday, June  $6^{\rm th}$ .

Mr. Bolster explained that there is a possibility of state offices shutting down should a budget not be passed. He stated that this would cause a negative impact on local governments across the commonwealth,

since all depend on monthly revenues from the state. He noted that the Department of Social services (DSS) will not be reimbursed as expected for their June, 2014, operations, but that he has spoken with local DSS Director Meredith Downey; she indicated that DSS has enough operating cash for about two months. He noted that DSS typically receives around \$119,000 per month from the state for operations. In addition, Mr. Bolster noted that the schools typically receive around \$1 million from the state per month to support their operations. As for the County, Mr. Bolster explained that around \$265,000 is received from the state per month as reimbursement for compensation board expenditures. He added that Regional Jail salaries are reimbursed from the state at around \$120,000 per month. All told, the County might be in jeopardy of losing around \$1.5 Million per month. Mr. Bolster then explained that spending levels for July 2014 thru September 2014 are anticipated to be around \$8.8 Million. He stated that the Board should consider freezing discretionary spending should the state not pass a budget.

Mr. Suter explained that the Board may also want to look at placing the County on a hiring freeze and appropriating funds quarterly versus annually until a decision is made by the state. He also explained that Mr. Bolster had previously spoken with County Treasurer Betty Trovato to ensure cash liquidity. Mr. Suter explained that Ms. Trovato will move cash from maturing CDs into more liquid assets.

Chairman Higgins asked Mr. Suter to add a discussion on the state budget to the upcoming Agenda. He also asked Mr. Suter and Mr. Bolster to look into ways the County could reduce vehicle usage and cut fuel expenses, to be discussed with the Board in July.

Mr. Bolster then reviewed the School Appropriation Resolution and recommended approval of the proposed resolution.

In addition, staff collaborated with Draper Aden and Associates to complete an updated review on the anticipated cost for the project. This information was provided to Ms. Perry as part of Perry has restated a landfill reimbursement for efforts. Ms. Authority's and the Board's consideration. The primary changes involve providing additional detail on the scope of the project and a change in the estimated maximum principal amount of the borrowing by the issuer for the project to ensure complete coverage on the future reimbursement request." Following his brief review, Mr. Bolster recommended approval of the resolution by the Board.

**WHEREAS**, the Rockbridge County Solid Waste Authority (the "SWA"), as owner, and the County of Rockbridge (the "County"), as current operator, have determined that solid waste disposal for county citizens and the region is a vital public service; and,

**WHEREAS**, the SWA and the County have determined that expansion of the existing RCSWA Landfill located at 321 Landfill Road, Buena Vista, Virginia 24416 (the "Landfill") is the preferred means of providing for future solid waste disposal in the County; and,

WHEREAS, the project at the Landfill shall include costs for (i) engineering services, studies, various exploration and monitoring activities (including multiple wells at the Landfill), permitting fees and related expenses, (ii) acquisition, construction and equipping of office facilities, scales, liner systems and leachate systems at the RCSWA Landfill, including road construction and improvements and mass excavation for such undertakings, and (iii) payment of issuance expenses in connection with any financing(s) of such undertakings (collectively, the "Landfill Expansion Project"); and,

**WHEREAS**, the County and the SWA (either or both, the "<u>Issuer</u>") have proceeded with due diligence and now propose to finance the Landfill Expansion Project with proceeds from the issuance of revenue bonds or other tax-advantaged obligations; and,

**WHEREAS,** the Issuer, on April 8, 2013, duly approved a Declaration of Official Intent to Reimburse Expenditures for the Landfill Expansion Project (the "Prior Reimbursement Resolution") with respect to the issuance of up to \$6,525,000 tax-advantaged obligations in connection with the financing of the costs of Landfill Expansion Project (as described in such Prior Reimbursement Resolution).

**WHEREAS**, the Issuer now desires to amend, supplement and restate the Prior Reimbursement Resolution and adopt this Amended and Restated Resolution Declaring Official Intent (this "Restated Resolution") in order to reflect the Issuer's current expectations with respect to the scope and financing of the Landfill Expansion Project.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of Rockbridge County, Virginia, and the Board of the Rockbridge County Solid Waste Authority, pursuant to the requirements of the United States Treasury Regulations Section 1.150-2, that this Restated Resolution shall constitute a declaration of official intent to reimburse certain prior expenditures in connection with the Landfill Expansion Project.

#### **BE IT FURTHER RESOLVED** that:

- 1. Expenditures to be incurred. The Issuer has incurred (and will incur) expenditures (the "Expenditures") in connection with the Landfill Expansion Project as described above.
- 2. Plan of Finance. The Issuer intends to finance the costs of the Landfill Expansion Project with the proceeds of debt to be issued by the Issuer in one or more series (including interim financing, if necessary or convenient, the "Borrowing"), the interest on which is to be excluded from gross income for Federal income tax purposes (or other tax-advantaged debt obligations).
- 3. Maximum Principal Amount of Debt to be Issued. The estimated maximum principal amount of the Borrowing by the Issuer for the Landfill Expansion Project is \$7,100,000.
- 4. <u>Declaration of Official Intent to Reimburse</u>. The Issuer hereby declares its official intent to reimburse itself with the proceeds of the Borrowing for the Expenditures made on and after the date that is no more than 60 days prior to the date hereof. The Issuer reasonably expects on the date hereof that such Expenditures will be reimbursed with the proceeds of the Borrowing.
- 5. Allocation Matters. Each of the Expenditures has been (and will be) of a type properly chargeable to a capital account under general federal income tax principles. The Issuer will make a reimbursement allocation to evidence the use of proceeds of the Borrowing to reimburse any Expenditures no later than 18 months after the later of the date on which the Expenditures are paid or the Landfill Expansion Project (or any component thereof, as applicable) is placed in service or abandoned, but in no event more than three years after the date on which each of the Expenditures is paid.

# Virginia Horse Center- Joint Discussion with the EDA

Chairman Higgins provided the Economic Development Authority (EDA) the opportunity to call their meeting to order.

Chairman of the EDA, Mr. Lynn Jones, called their meeting to order at 5:52 P.M.

County Administrator Spencer Suter provided handouts to those present of a draft Performance Agreement. He then provided a brief history of the Virginia Horse Center request stating that, in April 2014, the Board of Supervisors received a request from the Virginia Horse Center (VHC) asking the Board to consider increasing the lodging tax by 1% in support of the V HC. He stated that this support would come in two (2) forms: payment of debt service and assistance with capital maintenance projects. He advised

that, since this request was made, the City of Lexington has adopted an ordinance raising their tax by 1% with an effective date of August 1, 2014. Mr. Suter explained that the County solicited and received feedback from tourism groups, including lodging representatives, regarding the proposed increase. He stated that in order to build a solid mechanism for an agreement, the EDA was brought into the discussion, at which time the Board scheduled a public hearing for June 23, 2014 on the taxation ordinance to consider increasing the lodging tax. Mr. Suter briefly reviewed each page of the draft Performance Agreement and asked the Board and EDA to further discuss the draft Agreement and provide staff with any additional comments.

EDA member Ms. Janie Harris asked a question about section IV letter (e) of the agreement, related to default by the VHC. Ms. Harris's question was whether or not the EDA would be considered a creditor in the event of default by the VHC through the sale of the VHC.

County Attorney Vickie Huffman stated that the EDA would not be considered a creditor as the agreement is currently drafted, because it is set up as a payment, not a loan.

Ms. Harris asked if the agreement could be amended to allow the EDA to receive a portion of the funds from the selling of the VHC in the event that the VHC is sold.

Ms. Huffman confirmed that such an amendment is possible.

Supervisor Ford asked if ownership of the VHC, following default, would go to the USDA to be resold to any and all bidders.

Ms. Huffman stated that the VHC property is subject to the lien of the USDA, so if there were default on the USDA loan, the USDA could foreclose.

Ms. Harris shared her concern over the amount of land at the VHC that could be sold in portions to service debt. She asked that language be added to the agreement that, whether the entire facility is sold or just portions, the EDA be reimbursed for contributions made to the VHC from the proceeds of the sale.

Ms. Huffman asked Ms. Harris to clarify what contributions she was referring to in her previous request.

Ms. Harris explained that she was referring to the proceeds of the 1% additional new tax.

Ms. Huffman stated that, in the event of default, the USDA loan would take precedence and if the security of the USDA loan were equal to or in excess of what was owed, then there would not be any remaining funds.

Mr. Suter suggested taking the draft agreement back and researching the feasibility of adding the language suggested by Ms. Harris in the next draft agreement.

Chairman Higgins stated that the VHC could not be sold to an individual, but only sold to another non-profit organization.

EDA Chairman Jones asked if the 1% tax increase would continue to be paid to the USDA should the VHC file for bankruptcy.

Chairman Higgins stated that the agreement would no longer be valid, should the VHC declare bankruptcy.

Ms. Huffman confirmed that, in the event of default on the part of the VHC, the agreement would automatically be terminated as written in the Performance Agreement.

Supervisor Ford reminded the Board that VHC Treasurer Tom Clarke was planning a visit to USDA to try to renegotiate the interest rate of the USDA loan existing prior to February 6, 2007. He then asked what would happen to the balance of the proceeds of the current 2% tax collected should negotiations be successful and the 2% proceeds be more than enough to make the required annual payment.

Ms. Huffman stated that the 2% tax must be paid toward the USDA loan as agreed upon on in the agreement dated February 6, 2007. She noted that, should there be a surplus generated by the 2% tax collected, the surplus would be paid toward principal. The other option would be to revise the ordinance.

Supervisor Hinty asked Mr. Bolster how much lodging tax is collected each month.

Mr. Bolster responded that approximately \$35,000 is now collected monthly.

Mr. Hinty noted that, should lodging continue to increase, there will be enough tax collected to pay off the debt service without having to increase the lodging tax 1% as proposed.

Mr. Suter stated that the proposed 1% tax could then be used for other tourism related projects.

Chairman Higgins asked the County Attorney to clarify that the proposed 1% could be used for other projects related to the EDA.

Ms. Huffman stated that the Board could determine whether or not those funds need go through the EDA. Regardless, she noted, the Board would have to approve how those funds were used. She then noted that there is only one restriction to use of the proposed new funds, and that is that the funds be spent only on tourism related projects.

Supervisor Campbell stated that he had previously given the Board a list of things to consider adding into the draft agreement. The first amendment he requested was to add, "Whereas the VHC is encouraged to add a new sports complex," or something similar. The second amendment he requested was to add an additional "Whereas" following the third "Whereas" on page two of the agreement, to say something to the effect of, "Whereas the VHC shall not refinance the debt service without the approval of the Board of Supervisors". The third amendment he requested was to add language to the bottom of page two of the agreement that the Board of Supervisors be consulted on any future dedication of conservation easements on portions of the VHC property.

EDA Member Stephen Beck agreed with having the Board of Supervisors oversee any future dedication of conservation easements.

Supervisor Lewis indicated that he is in full support of sports complexes in the County but suggested not adding that language to the agreement.

Supervisor Hinty asked VHC Treasurer Tom Clarke to explain what is projected following the refinancing of the USDA loan.

Mr. Clarke explained that there would be two options the VHC could consider during negotiations of refinancing the loan. The first option would be to refinance and borrow additional funds to be used for safety-related capital maintenance expenses. The second option would be to refinance and not borrow the savings from the refinancing but, instead, reduce the term of the loan.

Supervisor Campbell suggested adding language to the agreement that will be beneficial in the long-term.

With no further business to discuss, the EDA closed their meeting at 6:34 P.M.

Chairman Higgins provided a nine (9) minute break before returning to the Board of Supervisors meeting at 6:44 P.M.

## Concurrence of School Division VRS Selection

Mr. Bolster briefly reviewed the Agenda Item: "The Virginia General Assembly passed legislation during its 2012 session allowing School Divisions, by resolution, to adopt rates for the non-professional group which are lower than the rates certified by the VRS Board of Trustees, with the shortfall being made up over the next three biennia. The intent of the legislative language was to provide local governments and school divisions some budget relief for the upcoming fiscal years related to their retirement contribution level. The opportunity to select an alternative rate does not change the VRS Board-certified rate. In June 2012, the School Board adopted the certified rate, with the assumption

that they would continue to do so for each of the subsequent four biennia. On June 3, 2014, the School Board adopted the full, VRS-certified rate of 8.51% for the non-professional group for FY 2015 and FY 2016 (the certified rate is higher than the alternate rate). Staff recommendation is to concur with the School Board's selection to adopt the VRS-certified rate. Acceptance of this recommendation will relieve the County of the requirement of calculating the School Division's deferred liability and noting it in the County's financial statements, allow professional group pool to become fully funded sooner, avoid having fewer assets available for benefits, and assure a lower funded ratio for the next actuarial valuation."

Supervisor Ford moved to adopt the proposed resolution. A second was provided by Supervisor Lewis, and the resolution was adopted upon unanimous roll call vote by the Board.

## Consideration of Erosion and Sediment Control Contract

Mr. Suter briefly reviewed the Agenda Item: "On May 12<sup>th</sup>, the Board of Supervisors approved staff rankings of proposals submitted by firms to provide plan review for Erosion and Sediment Control [E&S] and Stormwater Plans for the County of Rockbridge. Negotiations have resulted in a draft contract with the top-ranked proposer, Joyce Engineering. To recap, the contract would provide for external review of detailed E&S and Stormwater management plans. The fee schedule submitted by Joyce Engineering is in line with the review fees adopted by the Board in the May 28 Stormwater Ordinance revision public hearing. Should any future trending indicate

that the fees assessed by the County tend to over- or under-charge, based on contracted costs, the ordinance could be revisited and the fee schedule adjusted. At the time of writing, negotiations on the specifics of a contract with Joyce engineering were in progress but were not yet complete. However, ongoing discussions/negotiations do not involve the set proposed fee schedule. Services associated with a new contract would commence on July 1. The contract would be for a period of two years, with the option for two, two-year renewals." He went on to note that a draft contract had been reached and copies distributed for Board review.

# Consideration of contract for outside agency production of the Solid Waste Development Plan

Mr. Suter briefly reviewed the Agenda Item: "As presented at the May 29th Rockbridge County Board of Supervisors meeting, three proposals were received on April 3, 2014 in response to the County published RFP# 2014-02-001 'Outside Agency Production of Solid Waste Development Plan'. The Solid Waste Subcommittee determined that SCS Engineers would be selected for an initial interview, based on the published criteria. Subsequently, an interview was held on April 29, 2014, which resulted in the development of a revised scope of services. A revised scope of services document, including cost information, was provided to the County by SCS Engineers on May 14, 2014. Total cost for the comprehensive Solid Waste Development Plan and reporting is not to exceed \$38,000. Funding of \$15,000 was

approved in the current FY 13-14 budget for this project. Additional funding of \$23,000 has been identified under FY 13-14 'Contracted Services' line 11-42030-3001, due to better management of the contract and the closure of the "Old Drive-In" dumpster site on Rt. 501. The funds will be transferred during the current fiscal year and carried over to FY 14-15 as necessary to continue the project to completion. An agreement fully outlining the terms and conditions has been prepared by staff and the County attorney. Several minor changes have been requested of SCS. The document is currently being reviewed by SCS Engineers and may require some additional input from the County Attorney pending any additional questions raised by SCS Engineers."

Supervisor Ford moved to authorize staff to finalize any necessary contract language, execute the contract, and begin work on the project. Supervisor Campbell provided the second, and the motion carried by unanimous roll call vote by the Board.

## Consideration of LEOS Resolution

Mr. Suter briefly reviewed the Agenda Item: "As you may recall, the Commonwealth has mandated that, with a few exceptions, employees hired after January 1, 2014 be covered under the State's new 'Hybrid' retirement plan. Included in the list of exceptions are Law Enforcement and Fire/EMS employees. Director of Fire and EMS Craig Bryant was hired as a fully certified Fire/EMS responder, with the intent that he be covered under the traditional Virginia "Plan 2" retirement plan. When we submitted his credentialing to VRS, it was learned that the County must first adopt a resolution declaring full time Fire/EMS personnel inclusion under the LEOS plan, similar to previous actions taken on behalf of Law Enforcement personnel. It is important to note that this irrevocable resolution will have lasting impacts, should the County ever hire full-time Fire/EMS personnel. However, inclusion of Fire and EMS personnel been under the

LEOS program has become the standard in this region." He then recommended approval of the resolution to elect benefits equivalent to those provided under the State Police Officer's retirement system for full time salaried firefighters and emergency medical technicians.

Be it further resolved that Spencer H. Suter, County Administrator, and Spencer H. Suter, Clerk, be and they are hereby authorized and directed in the name of the County of Rockbridge to execute any required contract in order that the above described employees of the County of Rockbridge may become entitled to retirement benefits equivalent to those provided for State police officers of the Department of State Police. In execution of any contract which may be required the seal of the County of Rockbridge shall be affixed and attested by the Clerk and, said officers of the County of Rockbridge are hereby authorized and directed to do any other thing, or things, incident and necessary in the lawful conclusion of this matter. The Treasurer of the County of Rockbridge be and is hereby authorized and directed and pay over to the Treasurer of Virginia from time to time such sums as are to be paid by the County of Rockbridge and its employees for this purpose.
